



## **Club Rising Giveaway Official Rules**

Raffle contest begins 1/1/2018 and ends 12/31/2018. This promotion is in no way sponsored, endorsed or administered by Phoenix Rising Football Club or any company affiliated with the prizes. By participating in the contest, contestants understand that Arizona Federal may use their information to contact them in the future with offers.

### **ELIGIBILITY**

To be eligible to win the Club Rising Giveaway, you must be a member of Arizona Federal. If you are under the age of 18, you must have a parent or guardian agree in writing that they approve of your receipt of the prize. You must be listed as the primary member on a Club Rising Arizona Federal youth account. You must be a legal resident of the 50 United States, the District of Columbia, or Puerto Rico and not be an employee of Arizona Federal Credit Union at the time of the winner selections. Employees, volunteers and immediate family (parents, grandparents, children, siblings, spouses and individuals living in the same household) of Arizona Federal Credit Union, Phoenix Rising Football Club, and its affiliates are not eligible to win.
